B. SETTLEMENT DISCOUNT

- A 5% discount is offered if annual school fees are settled in full by latest 31 January.

C. COMPULSORY ADDITIONAL CHARGES

Registration fee

A non-refundable registration fee of R500,00 (Five Hundred Rand) is payable upon receipt of an application form.

Non Refundable Enrolment Fee

A non-refundable enrolment fee of R3000,00 (Three Thousand Rand) is payable upon acceptance of an offer letter.

Grade excursions will be held annually and attendance is compulsory. Parents will be informed of the cost and venue prior to the tour taking place.

No participation will be permitted should your school fees account be in arrears.

Grade 1 -7 Excursions (Excluded from the School Fees)

Grade Camps are held annually for pupils in Grades 4 to 7 and attendance is compulsory. Parents will be informed of the venue prior to the camp taking place. No participation will be permitted should your school fees account be in arrears.

D. VOLUNTARY AFTERCARE

St Peters offers voluntary aftercare service from Grade RRR to Grade 7. Pupils enrolled in aftercare will enjoy a healthy snack and supervision. Besides the main purpose of offering pupils, a safe and stimulating environment to stay after school, pupils are assisted with homework in the classrooms from Grade 1 to Grade 7.

E. SCHOOL FEE STATEMENTS

School fee statements emailed to parents. It is the parent's responsibility to inform the Finance Department if statements have not been received by email. Parents are required to advise the school of any changes in their email addresses.

F. PAYMENT TERMS

Fees are due and payable in advance in eleven (11) monthly instalments at the beginning of each month January to November with the grace period up to the 07th of every month. Statements of accounts will be issued on the 15th day of the month preceding the billing month. Any additional charges are due on presentation of the statement.

G. LATE PAYMENT OF SCHOOL FEE

A late payment charge will be levied on all accounts not settled by the due date. Should you choose to make your payment after the 07th, be aware that the School will impose interest charges and commence with debt collection proceedings against you, in line with the School's Finance Policy. Interest not paid to the School by the last day of the month in respect of which such interest accrues will bear further interest at the same rate in the next month billing cycle.

H. DEFAULT ON PAYMENTS

Any defaults on payment will be handled in accordance with the St Peter's School Finance Policy. An electronic copy of the Debtors' Policy is available on request.

I. METHODS OF PAYMENT

i) Debit Order

Debit order instructions forms are compulsory and mandatory for ALL parents who opt to make School Fees payment in monthly instalments. Debit Order option date is 01st, 15th, 25th, 26th, 30th and last day of the month. There will be a penalty fee of R100 for unpaid/returned debit order.

ii) Electronic Funds Transfer

Parents who do not make use of the debit order facilities, are expected to ensure that payments are made in advance at the beginning of each academic year. Online payments directly into our bank account:
